I. Wake County Republican Convention

II. District Conventions and State Convention

2nd Congressional District Convention

The NC Republican Party has authorized 404 Delegates and 404 Alternate Delegates. The Committee nominates 397 Delegates (denoted as 2D) and 0 Alternate Delegates.

4th Congressional District Convention

The NC Republican Party has authorized 151 Delegates and 151 Alternate Delegates. The Committee nominates 151 Delegates (denoted as 4D) and 20 Alternate Delegates (denoted as 4A).

13th Congressional District Convention

The NC Republican Party has authorized 164 Delegates and 164 Alternate Delegates. The Committee nominates 130 Delegates (denoted as 13D) and 0 Alternate Delegates.

North Carolina Republican Convention

The NC Republican Party has authorized 717 Delegates and 717 Alternate Delegates. The Committee nominates 698 Delegates (denoted as ND) and 0 Alternate Delegates.
